LGBTQ+Stories: From Across the Globe to Around the Corner

Coming Out as LGBTQ: It's Not One Moment, but Several


It can feel like "coming out" is everywhere — people talk about coming as every letter of the LGBTQ acronym, coming out with mental illness. The New York Times has noted that the Orlando massacre has inspired more people to come out as gay.

But coming out usually isn't a singular pronouncement — an Ellen DeGeneres moment or a "Glee" moment.

Instead, it's a series of moments.

For Tia Bryan, a 30-year-old bisexual woman in Dallas, coming out is a process that happens every day. She and her fiancée feel supported by an accepting community, but she still finds herself explaining the ring on her finger to co-workers, strangers and friends. Leading up to their wedding next April, Bryan and her fiancée are experiencing a variety of coming-out moments — big conversations with family members as well as quiet public displays of affection.

"It's definitely a lot more than some proclamation," she says. "Even something as small



Bonnie Jo Morris, a professor of women's studies at Georgetown University, has collected her own comingout experiences in a one-woman show, celebrating the big and awkward to the small and easy. She points out that, for many people in the LGBTO community, coming out isn't an option in many situations — it's not safe.

"I've come out to people in hot tubs and on airplanes," she says. "But in some places I've traveled and it's been dangerous, and I have lied. Do you lie about a dead boyfriend just to be safe for 10 minutes? ... You're never off the hook for the rest of your life."

Pablo Ben, a history professor at San Diego State University, has researched the political history of coming out, tracing the movement to the Stonewall Riots in 1969, and even earlier to some groups in 1860s Germany, when activists were coming out as gay to their communities. Ben came out to his own family more than 20 years ago, but he still found himself "coming out" to a waiter at a coffee shop in Buenos Aires who assumed he was straight.

"There's always a certain degree and areas of life in which you come out and areas of life in which you don't," he says. "And there's always some areas of life in which you don't. I work at San Diego State University and I'm open over there, and I'm open to my family since my 20s. All my family in Argentina, I present at a lecture and everyone knows."

"But ... I go to a cafe and a waiter assumes I am straight," he says. "And I don't know — it's not about not being out, it's just like, I don't know if I don't have the energy to make it a topic. Sometimes, you don't want that interaction. You just want a coffee."

We collected stories from our followers on Tumblr, asking them to leave us a voicemail explaining what coming out means to them — when they've done it, how and what it felt like. Some talked about the first conversation; some discussed a single moment; others described an ongoing process. One caller, Gary Gates, summed it up pretty neatly: "I've never come out, and I'm always coming out."

After Pulse Shooting, LGBT Folks Of Color Worry About Increased Police Attention

After 49 people were killed at the Pulse nightclub in Florida in June, gay pride marches <u>across the</u> <u>country</u> saw <u>amped-up</u> police presence. Law enforcement agencies <u>shared support</u> for LGBT people on social media

and in the press. The NYPD rolled out a cop car decorated with rainbows. Safety and security for LGBT people became a political talking point. Donald Trumpdecried violence against LGBT communities in his "Law and Order" Republican National Convention speech. Calling the victims, who were mostly LGBT and Latino, "wonderful Americans," Trump promised "to protect our LGBT citizens."

Though some have <u>questioned the sincerity</u> of Trump's pledge, others have welcomed increased security at LGBT events and spaces. Still, some activists worry that more police presence won't protect them from vigilante violence — and might actually make these events less safe for the communities they serve.

In recent weeks, activists associated with the Black Lives Matter movement and organizations of LGBT people of color have <u>protested greater law enforcement participation</u> in gay pride parades around the country and have called on others to consider the needs of those vulnerable to police violence and harassment.

These activists say that while police pledge to protect some in LGBT communities, there are patterns of victimization toward others, especially those who aren't cisgender and white.

"The only way politicians can think to show solidarity with a community that's grieving and feeling deeply vulnerable is to have more of the people who make us feel deeply vulnerable and cause us to grieve," says Andrea Ritchie, a civil rights lawyer who is researching profiling and policing women of color as a <u>Soros Justice Fellow</u> and is the author of Queer (In)justice: The Criminalization of LGBT People in the United States.

Supreme Court blocks Transgender Victory on Bathrooms

The Supreme Court sided Wednesday with a Virginia school board opposed to the Obama administration's directive that transgender students be allowed their choice of public bathrooms.

The justices blocked a federal appeals court ruling against the Gloucester County School Board while they consider whether to hear the case. If they do, it would mark the high court's first foray into the issue of transgender rights.

The case was brought by a transgender student, Gavin Grimm, who contested the school district's refusal to let him use the boys' bathroom. The U.S. Court of Appeals for the 4th Circuit ruled in his favor in April but put its ruling on hold so the school board could appeal. The Supreme Court's order keeps the old rules in place.

The court's four conservative justices were joined by Justice Stephen Breyer in blocking the transgender student's earlier victory. The three other liberal justices said they would have denied the school board's request. The battle over so-called bathroom bills has played out in many states as Republican lawmakers seek to force students to use facilities that correspond to their gender at birth, and transgender students fight for the right to follow their gender identity.

Just last week, more than 100 pastors in the Midwest sent a letter to Ohio elected officials and school districts, calling for schools to ignore a May mandate from the U.S. Department of Education allowing transgender students to use bathrooms and locker rooms consistent with their gender identity.

The letter states the pastors believe "there is no authority except from God" and the U.S. Department of Education's directive to school districts "defies objectivity and logic." It also "jeopardizes the privacy and safety of vulnerable women and children," the pastors said.

In early July, 10 states sued the federal government over rules requiring public schools to allow transgender students to use restrooms conforming to their gender identity, joining a dozen other states in the latest fight over LGBT rights.

The July lawsuit was filed in federal court in Nebraska and included nine other states: Arkansas, Kansas, Michigan, Montana, North Dakota, Ohio, South Carolina, South Dakota, and Wyoming.

The filing comes after 11 states sued in May over the same Obama administration directive. North Carolina officials also sued the federal government in May over the same issue. Vast sums of federal funding are at stake: Money could be withheld from public schools that refuse to comply with the federal directive.

NBA Pulls 2017 All-Star Game Out of Charlotte, North Carolina, Over 'Anti-LGBT' Law

The <u>NBA</u> has pulled its 2017 All-Star Game out of Charlotte, North Carolina in the wake of the passage of a controversial measure that has been criticized as anti-LGBT.

"The NBA has decided to relocate the 2017 All-Star Game from Charlotte," the NBA told ABC News today in a statement, adding that it would "make an announcement on the new location of the 2017 NBA All-Star Game in the coming weeks."

"Since March, when North Carolina enacted HB2 and the issue of legal protections for the LGBT community in Charlotte became prominent, the NBA and the Charlotte Hornets have been working diligently to foster constructive dialogue and try to effect positive change," the NBA said. "While we recognize that the NBA cannot choose the law in every city, state, and country in which we do business, we do not believe we can successfully host our All-Star festivities in Charlotte in the climate created by HB2."

The NBA's decision comes after North Carolina's General Assembly failed to repeal HB2 during its last session of the year earlier this month.

HB2 prohibits most transgender people from accessing bathrooms in government offices and schools that correspond to the gender with which they identify. It also bars local municipalities from creating their own rules prohibiting discrimination in public places based on sexual orientation and gender identity.

Since lawmakers weren't scheduled to reconvene until January of next year -- and the All-Star Game was scheduled to happen in February -- the NBA faced increasing pressure over the past few weeks to officially move the game.

Two weeks ago, technology industry leaders sent a letter to NBA Commission Adam Silver and urged him to move the upcoming game out of North Carolina, according to The Associated Press. The letter was signed by executives from famous companies including Google, Reddit, PayPal, Lyft and Pinterest.

"If the NBA holds events in North Carolina while HB2 remains law, players, employees, and fans will be at risk of discrimination — and that's wrong," read the letter obtained by the AP. "The NBA has nothing to lose by taking a stand alongside hundreds of other companies and showing support for its LGBTQ players, employees, and fans."

<u>Jerusalem Pride marches forward one year after fatal parade stabbing</u> By Erin Rook of <u>LGBTQ Nation</u>

A record 25,000 people attended this year's <u>Jerusalem Pride Parade</u> amid heightened security following last year's fatal stabbing, <u>the Jerusalem Post reports</u>.

No injuries were reported during the Jerusalem March for Pride and Tolerance, though <u>heavily armed police officers</u> arrested 30 protestors and confiscated two knives. During the 2015 parade, a radical ultra-Orthodox Israeli Jew stabbed 16-year-old Shira Banki to death and attempted to kill seven others.

Yishai Schlissel was convicted of <u>murder</u> and attempted murder and sentenced last month to life in prison plus 31 years. But even from prison, Schlissel allegedly asked others to carry out attacks on the LGBTQ community on his behalf. <u>The Jerusalem Post reports</u>:

Hours before the parade began at Liberty Bell Park, police announced that Schlissel – who stabbed Banki, 16, and six others, days after being released from prison for committing a similar crime 10 years earlier – was rearrested for conspiring with his brother to carry out more attacks from prison.

Last year's tragedy brought new people to the parade, ranging from straight seniors to LGBTQ and straight teens and a gay Jewish couple from New York who showed up at the behest of LGBTQ Israelis.

"As an Orthodox person, I should be supporting this parade and supporting the rights of gay people and equality in Israel — especially after the horrible murder of Shira Banki," Yoav, a 19-year-old straight Orthodox Jew told the Jerusalem Post while wearing a yalmuka and gay pride T-shirt. "I see it as my religious duty to be here and support the [LBGT] community....As a religious person, I think it's your duty to support every minority group, and to help them get equality."
